INSTITUTIONAL REPORTS

Foundation Institutional Report

Executive Director of the State Fair Community College Foundation Mary Treuner reported on the Foundations activities.

To show the growth and generosity we have experienced she compared the FY14 Total assets of \$13,235,000 to the FY24 Total assets of \$34,544,000. We are one of the top foundations in MO. We live in a very giving community, but it comes from years of building relationships.

Ms. Treuner spoke of how scholarships are awarded and pointed out that in Athletics that the Booster Club golf tournament goes directly to athletics. She thanked Jennifer Hubbs in Financial Aid for doing a fantastic job keeping scholarships in line with a new process that she initiated.

Capital Campaign update: CAATT campaign is really gaining speed, so we are optimistic on the fundraising now that the building is being seen. We have been giving many tours to

community leaders, etc.

Dr. Bates complimented Mary and the foundation team for all their work.

Teaching and Learning Innovation Center

Associate Dean Dr. Cara Barth-Fagan reported that in March she created a committee to work on the first Strategic Theme, which is to Ensure Exemplary Teaching and Learning. Their FAST Goal is to create a Center for Teaching and Learning Innovation. The team also worked on their mission statement and a vision statement and interviewed other colleges with a similar Centers of Excellence.

The Mission Statement was created by Deaven Kaiser, Danika Doyle, Jamie Privitt, Brandon Henderson and Dr. Barth-Fagan and says: *The State Fair Community College Center for Teaching and Learning Innovation (CTLI) is dedicated to fostering a culture of excellence and innovation in teach and learning. Our mission is to empower educators to enhance student learning outcomes through evidence-based practices, transformative pedagogies, and the integration of emerging technologies.*

They will be providing training sessions and will reach out to new faculty who haven't been in the classroom much. Dr. Barth-Fagan is visiting all the divisions and asking for suggestions on availability for professional development and ideas for what they want to learn.

For the Fall Break, they have created professional development opportunities for that week, which will include some great topics such as neurodiversity, active shooter response, Care Team, etc.

Dr. Bates thanked Cara for her leadership in this.

DESE AREA CAREER CENTER CONSTRUCTION GRANT

Mr. Carr moved that the Board of Trustees authorize the President to accept the DESE Area Career Center Construction Grant as described. Mr. Page seconded the motion; motion carried (Yes-6; No-0).

Missouri House Bill 2 in the Missouri FY 2025 DESE budget allocated \$5,500,000 to the Department of Elementary and Secondary Education (DESE) for the design, renovation, construction and improvements of career technical schools, provided that the local matching funds must be provided on a 50/50 state/local basis. State Fair Community College applied for, and has been awarded \$700,000 for the CTC portion of the Center for Advanced Agriculture and Transportation Technology design and construction. Funds must be spent by May 15, 2025.

This makes it consistent with all the other administrative positions at the college. He also would like to add that the Executive Director of Human Resources facilitate the evaluation process as directed by the Board of Trustees.

Policy 8200 Appropriate Use – Most changes were updating language and removing some of the items to Regulation.

Policy 9100 Introduction and Oversight – Previously stated that BOT authorized the Marketing and Communications office; however, Policy 0340 says that the Board gives the President the authorization to do this.

Mr. Parker moved that the Board of Trustees approve Policy 1375 – a new policy for Honorary Degrees. Mr. Hubbs seconded the motion; motion carried (Yes-6; No-0).

Mr. Parker moved that the Board of Trustees approve the deletion of Policy 1390. Mr. Page seconded the motion; motion carried (Yes-6; No-0).

Mr. Parker moved that the Board of Trustees approve revisions to Policy 0411, Policy 0510, Policy 1333, Policy 8200, and Policy 9100 as presented. Mr. Hubbs seconded the motion; motion carried (Yes-6; No-0).

Mr. Parker moved that the Board of Trustees approve the substitute language proposed of Policy 1523 (this new language was presented in writing to the Board); Mr. Hubbs seconded the motion; motion carried (Yes-6; No-0).
