- Minimum 14,000 lb. capacity
- Scissor style lift
- Surface Mount
- Open front and rear style lift
- Maximum overall width 92.5"
- Minimum max raise height of 72"
- Maximum overall length 280" with ramps
- Maximum time to reach max height 70 seconds
- Must include 2 rolling air jacks, 9,000 lbs. lifting capacity
- Must integrate with Hunter WA684-CM alignment console for automated operation
- Include front turn plates to allow for alignments to be completed.
- Include rear slip plates to allow for four-wheel alignments to be completed.
- Include fluids to fill and make operational after installation
- Lift must be capable of allowing for two-wheel alignment of wheelbases up to 195"
- Lift must be capable of allowing for four-wheel alignment of wheelbases up to 168"
- Runway width should be a minimum of 26"
